AWA Inspection and Annual Reports

USDA Animal Care inspectors conduct routine, unannounced inspections of all entities licensed or registered under the Animal Welfare Act.

Inspectors conduct three types of inspections:

- Pre-licensing inspections to make sure the applicant can meet the Federal standards prior to being licensed or registered;
- Routine, unannounced compliance inspections of all entities to make sure they are adhering to the Federal standards and regulations; and
- Focused inspections based on public complaints or allegations of unlicensed activities.

During routine inspections, USDA reviews the premises, records, husbandry practices, program of veterinary care, and animal handling procedures to ensure the animals are receiving humane care. The frequency of inspections is based on several factors, including an entity's compliance history. USDA inspects research facilities that use regulated animals at least once a year.

Inspection Reports

APHIS is committed to ensuring the welfare of regulated animals and continues to carry out the critical day-to-day work of ensuring the humane treatment of vulnerable animals through unannounced inspections, compliance visits, horse protection inspections, and other activities.

Records will be released when authorized and in a manner consistent with the FOIA and Privacy Act. Also, consistent with recent amendments to the FOIA, if the same records are frequently requested records under the FOIA and are subject to release under the FOIA and Privacy Act, APHIS will post the appropriately redacted versions to our website.
